

When loading the picture on your profile, ensure the picture is correctly rotated.

TESTING OF YOUR DEVICES CAMERA

Before you write the examination, ensure the camera on your device is working. The operating system on most devices has an inbuilt camera app. Select the start button and select the camera from the list of apps. Open the app and ensure that you can see a clear image of yourself. Allow the camera app to use your webcam, your microphone and location if you cannot see an image of yourself.

Please be aware of the following:

- You may not wear anything that is covering your face.
- Avoid sitting in front of a window or light source. Alternatively, close curtains or blinds.
- Ensure that your camera is correctly positioned so that your face is in the middle of the screen.

When will you receive your results?

Results will be released once they have been verified and approved by Council.
