



SAPC e-Note: INVITATION TO ATTEND CPD WEBINAR FOR PHARMACISTS

Dear Pharmacist,

Final reminder to comply with 2025 CPD requirements before 28 February 2026, and invitation to a CPD webinar

According to our records, you have not yet complied with the 2025 Continuing Professional Development (CPD) requirements by submitting at least six (6) CPD entries for the year 2025. Please find the attached letter concerning your non-compliance with CPD requirements and the implications thereof. The South African Pharmacy Council (SAPC) reminds you that the grace period granted to you to comply with the 2025 CPD requirements ends on **Saturday, 28 February 2026**.

There will be no extension to the grace period. Should you not be compliant with the 2025 CPD requirements by the end of the compliance grace period, you will be designated as a Non-Practising Pharmacist, and your registration as a Responsible Pharmacist and/or Tutor will be removed. **A non-practising designation will mean that you will no longer be entitled to practise any or all the prescribed scope of practice of a pharmacist, or to perform any act which you, in your capacity as a registered person, are entitled to perform.**
