The SAPC conducts a **COMPULSORY** Pre-registration Practice Examination for interns intending to sit for the pre-registration examination. Bookings for the practice examination have opened and will close on **Monday, 31 August 2026**. The Pre-registration Examination will be held on **20/21 October 2026**.

Please inform the SAPC before **Monday, 31 August 2026**, if you are unable to book due to technical issues and submit a screenshot as proof. The SAPC will not attend to any appeals sent after the booking closing date.

NB!!! Entrance requirements for the 2026 Intern Pre-registration Examination are as follows:
Interns must be in their sixth (6th) month of internship and:

- must have submitted at least six (6) Portfolio of Evidence entries online and be competent in at least three (3) entries;
- must have completed the practice examination; and
- their tutor must have submitted three (3) progress reports.

Interns in their ninth (9th) month or more must have:

- submitted and be competent in all six (6) Portfolio of Evidence entries;
- completed the practice examination; and
- their tutor must have submitted four (4) progress reports.

Interns reattempting the examination:

- for the second or subsequent attempts, must be competent in all six (6) Portfolio of Evidence entries to be allowed to sit for re-examination; and
- their tutor must have submitted the relevant progress reports according to the intern's date of registration.
