Do you know a pioneering Pharmacist's Assistant or Pharmacy Technician who is making an impact in their pharmacy or community? The South African Pharmacy Council (SAPC) invites nominations from colleagues or managers of exemplary Pharmacy Support Personnel for the 2026 National Pioneer Pharmacy Awards.

The Pharmacy Support Personnel Award is awarded to a pharmacy support professional who exhibits the highest professional standards and performs consistently and reliably as a valued member of the pharmacy team, going beyond the call of duty. This award seeks to encourage and reward pharmacy support personnel who are working to streamline work flow processes, improve safety and/or improve patient outcomes.

Submitted nominations should meet the following criteria:

- Registered with the SAPC;
- Qualified and practising as a qualified Pharmacist's Assistant or Pharmacy Technician for at least two (2) years;
- Completed Online Nomination Form;
- No recent finding (five (5) years) against the Pharmacist's Assistant or Pharmacy Technician by the Committee of Formal Inquiry of Council and no pending disciplinary case at that Committee.
- Electronic ID photo in .jpeg format (300dpi)
- Brief CV (not more than 150 words) (Content: Brief history of the nominee with clear description of outstanding achievements, contributions and/or service excellence.)
- Comprehensive motivation for why the nominee has made a difference in any sector of the pharmacy profession that has had an impact on patients.
- In addition, quantifiable, measurable evidence that the nominee streamlined workflow processes, improved safety and/or improved patient outcomes. The whole report must not exceed two (2) pages per nominee.
- Letter of motivation from the Responsible Pharmacist and/or Pharmacy/Dispensary Manager.
- Between one (1) and three (3) supporting/recommendation letters/reports may be included **(not compulsory to attach, but advantageous)**.

How to nominate?

1. Complete the [Nomination Form](#) and fill in the "Contact details of the Nominee Pharmacy Professional" and "Contact details of the Nominator". **No need to fill in the "Contact details of**

the Nominee Pharmacy Facility”, when nominating Pharmacy Support Personnel or a Pharmacist.

2. Compile electric copies of all the required documents as per criteria above, including the signed nomination form.

The extended closing date for nominees is **Friday, 10 July 2026**.
